RESOLUTION RATIFYING THE 2020-2022 LOCAL NUTRITION ACTION PLAN OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, Article XV, Section 3 of the 1987 Philippine Constitution mandates that “the State shall defend the rights of children to assistance, including proper care and nutrition”;

WHEREAS, landmark legislations enacted at the national level are PD 491 (Nutrition Act of 1974), PD 1569 (Strengthening the Barangay Nutrition Program), RA No. 8172 (Salt Iodization Law), RA No. 8976 (Food Fortification Law), and RA No. 11148 (Kalusugan at Nutrisyon ng Mag-Nanay Act-First 1000 Days Law);

WHEREAS, the Municipal Nutrition Council (MNC) has formulated a Municipal Nutrition Vision “*Nationally known for its nutrition transformative efforts towards a sustainable, nutritionally-improved and malnourished-free Tigbauanon*” and Mission, “*To provide nutrition-centered healthcare with excellence in quality service and access through a multi-sectoral approach*” to incorporate in the Local Nutrition Action Plan for 2020-2022 (LNAP);




