## Resolution No. 2022-183

RESOLUTION AUTHORIZING ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR TO GRANT FINANCIAL ASSISTANCE AS DONATIONS TO THE PERFORMERS, DANCERS AND MUSICIANS/INSTRUMENTALISTS OF TRIBU SALUDAN, AN OFFICIAL PARTICIPATING TRIBE IN THE KASADYAHAN SA KABANWAHANAN 2023 REPRESENTING THE MUNICIPALITY OF TIGBAUAN, IN THE TOTAL AMOUNT OF ONE MILLION PESOS (P1,000,000.00) CHARGEABLE AGAINST THE BUDGET UNDER OFFICE OF THE MAYOR-DONATIONS.

**WHEREAS**, the Dinagyang Festival is one of the biggest festivals in the Philippines which is celebrated every 4<sup>th</sup> Sunday of January in honor of Senior Sto. Niño, the child Jesus;

**WHEREAS**, as part of a weeklong celebration of the Dinagyang Festival 2023, the Kasadyahan sa Kabanwahanan will be held on January 21, 2023 wherein the different towns in Iloilo Province and other provinces in Western Visayas will showcase their local festivals in a dance competition;

**WHEREAS**, the Iloilo City Government will give each participating town a subsidy of Five Hundred Thousand Pesos (P500,000.00) to assist in the conceptualization and preparation of their respective performances;

**WHEREAS**, the Local Government of Tigbauan initially allocated an additional Five Hundred Thousand Pesos (P500,000.00) as counterpart in support of the Tigbauan performers who will represent the municipality in said festival;

**WHEREAS**, during an emergency meeting called on December 21, 2022, attended by Municipal Mayor Virgilio T. Teruel, Municipal Budget Officer, Municipal Treasurer, Municipal Accountant, and Sangguniang Bayan Members to discuss the concerns of the tribe, an additional financial assistance in the amount of Five Hundred Thousand Pesos (P500,000.00) was agreed to be provided to meet the requirements of the tribe.
