RESOLUTION CONFORMING AND ADOPTING THE MUNICIPAL DEVELOPMENT COUNCIL EXECUTIVE COMMITTEE (MDC-EXECOM) RESOLUTION NO. 2022-04 DATED DECEMBER 23, 2022, ENTITLED: "RESOLUTION APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) CY 2022 FOR THE SUPPLEMENTAL APPROPRIATIONS CY 2022 FOR THE ONE-TIME GRANT OF RICE ASSISTANCE TO ALL GOVERNMENT EMPLOYEES AND WORKERS FOR FISCAL YEAR 2022 AS PER ADMINISTRATIVE ORDER NO. 02 DATED DECEMBER 16, 2022 WITH THE TOTAL AMOUNT OF ONE HUNDRED EIGHTY-ONE THOUSAND THREE HUNDRED PESOS (P181, 300.00) OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO"

WHEREAS, in a letter dated December 23, 2022, the Hon. Mayor, Atty. Virgilio T. Teruel, requested this August Body for the urgent passing of the aforementioned resolution;

WHEREAS, Section (4)(h) of Congressional Joint Resolution (JR) No. 4 (s. 2009) authorizes the grant of (i) incentives to reward an employee's loyalty to government service and contributions to the agency's continuing viable existence; (ii) incentives as rewards for exceeding agency financial and operational performance targets to motivate employee efforts toward higher productivity; and (iii) other existing benefits to be categorized by the Department of Budget and Management (DBM) as incentives;

WHEREAS, Administrative Order (AO) No. 2 dated December 16, 2022 authorized the grant of Rice Assistance to government employees (which includes municipal officials and employees) for Fiscal Years (FYs) 2019, 2020 and 2021 respectively in recognition of the hard work, commitment and dedication to public service of government personnel;

WHEREAS, the Local Finance Committee (with the composition, namely: Ms. Elma G. Tionsay, Municipal Treasurer, Mr. Jimmy T. Tupas, MPDC, Ms. Myra Gene G. Gautier, Municipal Budget Officer & Mrs. Mary Grace M. Trio, Municipal Accountant) had certified that the amount of ONE HUNDRED EIGHTY ONE THOUSAND THREE HUNDRED PESOS (P181,300.00) is

available in the Maintenance and Other Operating Expenses (MOOE) Savings to be used for the Grant of Rice Assistance to all Government Employees For Fiscal Year (FY) 2022;
