RESOLUTION ADOPTING THE DISASTER RISK REDUCTION MANAGEMENT PLAN FOR HEALTH (DRRMPH) FOR CY 2023-2025.

WHEREAS, the Local Chief Executive in a letter dated March 28, 2023 requested this Sangguniang Bayan for the URGENT passing of a "Resolution Adopting the Disaster Risk Reduction Management Plan for Health of CY 2023-2025;"

WHEREAS, the Municipality of Tigbauan, a component town of the Province of Iloilo, is a public corporation with dual function. Firstly it is functioning as a political government; and secondly, it is carrying out the function of the community in the administration of local affairs. It has fifty-two (52) component barangays, nine (9) of which are situated in the poblacion and the rests are scattered around the poblacion and spread up to the boundaries of the Municipalities of Oton, San Miguel, Tubungan, Leon and Guimbal;

WHEREAS, the Tigbauan Disaster Risk Reduction Management Plan for Health (DRRMPH) define the direction of the LGU in preparing for effective and efficient response and recovery in the event of emergency or disaster. This embodies a set of strategies and activities based on an analysis of the hazards, risks, and vulnerabilities of the LGU;

WHEREAS, the Preparedness Plan contains strategies and activities that the LGU will carry out to build local capacity to respond to emergencies, whereas the Response Plan lays down strategies and activities in utilizing LGU resources for effective and efficient response during emergencies;

WHEREAS, the Recovery and Rehabilitation Plan contains the strategies and activities to develop the LGU post-emergency and return to or exceed its original state;

WHEREAS, the Disaster Risk Reduction Management for Health (DRRMH)Plan shall be implemented by the LGU, led by members of the health sector concerned with emergency management with close support from other sectors;
