RESOLUTION ADOPTING THE MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT OFFICE (MSWDO) OPERATIONS MANUAL OF THE MUNICIPALITY OF TIGBAUAN

WHEREAS, Article XII, Section 1 of the 1987 Philippine Constitution states that, *“the goals of the national economy are a more equitable distribution of opportunities, income, and wealth; a sustained increase in the amount of goods and services produced by the nation for the benefit of the people; and an expanding productivity as the key to raising the quality of life for all, especially the underprivileged”*;

WHEREAS, the Department of Social Welfare and Development (DSWD) is mandated by law to do policy and program development, standard setting, technical assistance, and monitoring functions to local government units to effectively implement social welfare and development programs in target areas;

WHEREAS, the Municipal Social Welfare and Development Office (MSWDO) is the social welfare arm of the Municipal Government which coordinates, facilitates, plans and implements the needed services and programs to strengthen and improve the level of well-being of individuals and families in the locality;

WHEREAS, the Manual of Operations of the MSWDO embodies all the local programs as well as the policies and guidelines in carrying out said programs of the Municipal Government which include Child and Youth Welfare, Women’s Welfare, Persons with Disabilities Welfare, Senior Citizens, Family and Community Welfare, Emergency Welfare such as Food/Cash Assistance, Emergency Shelter Assistance and Assistance to Individual in Crisis Situation (AICS);

WHEREAS, the Manual of Operations of the MSWDO is an important and useful tool in carrying out the social welfare programs in the Municipality and thus, it needs to be officially adopted;

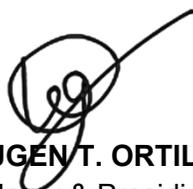
