RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM THE OFFICE OF HIS EXCELLENCY, PRESIDENT FERDINAND “BONG-BONG” MARCOS, JR., PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES, IN THE AMOUNT OF TWO HUNDRED MILLION PESOS (P200,000,000.00) FOR THE CONSTRUCTION OF RIVERBANK FLOOD CONTROL/COASTAL PROTECTION PROJECT ALONG SIBALOM RIVER OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, the Municipality of Tigbauan is a coastal town in the southern part of the Province of Iloilo, Region VI - Western Visayas;

WHEREAS, a major river known as Sibalom River traverses in the said municipality on its way out to the sea;

WHEREAS, the opening/gateway of the said river is situated along Brgy. 9, Poblacion and runs along Brgy. 8 and Tan Pael, this municipality, making the area vulnerable to storm surge, flood and erosion, putting lives and properties in danger;

WHEREAS, in June 2008, the Municipality of Tigbauan was among the municipalities in the Province of Iloilo ravaged by typhoon “FRANK” which caused loss of lives and tremendous damage to properties such as hanging bridges, municipal and barangay roads and bridges, school buildings, river dikes and the like;

WHEREAS, one main project, envisioned by the municipality is a beach forest project that would attract foreign and local tourists and investors. A project that would not only beautify the municipality but would also provide jobs and generate income to the LGU;

WHEREAS, one problem that remains an obstacle to this project is the threat of destruction that could be caused by nature like the overflowing of the Sibalom River during rainy season;

WHEREAS, to avert flooding and erosion, among the annual activities conducted by the municipality is the mangrove tree planting, however, such had proved to be futile as it could not withstand the force of water coming thru the Sibalom River;

WHEREAS, after discussions and deliberations, the officials of this Municipality have concluded that the construction of riverbank flood control/coastal protection project along the Sibalom River is urgently needed as a solution to said problem;

WHEREAS, with this predicament and faced with budgetary constraints, the Municipality of Tigbauan is requesting financial assistance from your good office;

RESOLVED, to Request Financial Assistance From the Office of His Excellency, President Ferdinand “Bong-Bong” Marcos, Jr., President of the Republic of the Philippines, in the Amount of Two Hundred Million Pesos (P200,000,000.00) for the Construction of Riverbank Flood Control/Coastal Protection Project Along Sibalom River, of the Municipality of Tigbauan, Province of Iloilo;
