Resolution No. 2023-124

RESOLUTION AUTHORIZING ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE ILOILO PROVINCIAL GOVERNMENT, REPRESENTED BY HON. ARTHUR R. DEFENSOR, JR., GOVERNOR ON THE EFFECTIVE IMPLEMENTATION, OPERATION AND GOOD GOVERNANCE OF THE INTEGRATED FARMING SYSTEM.

WHEREAS, in a letter dated September 11, 2023, the Local Chief Executive requested this Sangguniang Bayan for the URGENT passing of the aforementioned Resolution;

WHEREAS, the said Memorandum of Agreement shall be made and entered intoand between the following parties;

- The **PROVINCIAL GOVERNMENT OF ILOILO**, a local government unit created by laws of the Republic of the Philippines represented by Honorable Governor, **ARTHUR R. DEFENSOR, JR.** with postal address at Provincial Capitol Bldg., Bonifacio Drive, Iloilo City herein referred to as **“PROVINCE”**;
- The **MUNICIPALITY OF TIGBAUAN**, a local government duly created under the laws of the Philippines represented by Honorable Mayor **VIRGILIO T. TERUEL** with postal address at Tigbauan, Iloilo herein referred to as the **“MUNICIPAL LOCAL GOVERNMENT UNIT of TIGBAUAN or MLGU”**; and
- The **Beneficiary** with residence at Brgy. Doron –an, Tigbauan, Iloilo, **Mr. NOEL A. TUMASIS** referred to as the **“FARMER COOPERATOR”**.

WHEREAS, R.A. 8435 otherwise known as the Agriculture and Fisheries Modernization Act (AFMA) envisions to strengthen the Agriculture and Fisheries Sector through modernization to attain food security, poverty alleviation, income enhancement and profitability, and global competitiveness and sustainability;

WHEREAS, R.A. 7160 known as the Local Government Code of 1991 mandates the Municipal Local Government Units (MLGUs) to provide extension services and facilities related to agriculture and fishery activities to its constituents;

WHEREAS, the Province of Iloilo mandated to promote agricultural development through the community-based farm systems approach emphasizing social justice, equity, productivity, and sustainability in the use of agricultural resources is providing agricultural extension and on-site research services and facilities to ensure that maximum assistance and access to resources in the production, processing and marketing of agricultural and aquacultural products are extended to farmers, fishermen and local entrepreneurs;

WHEREAS, the Provincial Agriculture Office support farmers, rural women and youth with an ultimate objective of increasing family income;

WHEREAS, one way of obtaining its objectives is to adapt good agricultural practices through the INTEGRATED FARMING SYSTEM. The by-product of the system becomes the input of another linked component which would be equated to reduction of cost of production, increase in productivity per unit area, increase in total income and effective utilization of family labor all throughout the year;

WHEREAS, the parties herein, willfully and jointly agree to extend full support and cooperation for the effective implementation, operation and good governance of the above-mentioned project;

WHEREAS, for and in consideration of the foregoing premises and of the mutual covenants stipulated herein, the PARTIES hereby agree to enter into this MEMORANDUM OF AGREEMENT to adhere to the following terms and conditions.

1. The **Provincial Government of Iloilo** shall:

- a. *Conduct project site and beneficiary validation, verify accuracy of submitted project documents and assess the feasibility of the projects whenever necessary;*
- b. *Provide inputs and implement the project in accordance with approved plans and programs and ensure that the funds are properly utilized and disbursed according to standard government accounting and auditing procedures;*
- c. *Provide the necessary technical assistance to ensure smooth implementation of the project;*
- d. *Conduct regular monitoring and evaluation of the project;*

1. The **Municipal Local Government Unit** shall:

- a. *Identify and recommend Integrated Farming System (Palayamanan Model) farmer recipient;*
- b. *Provide technical assistance in the establishment of the project;*
- c. *Provide other agricultural inputs;*
- d. *Conduct continuous monitoring and evaluation to ascertain the status of the project implementation;*
- e. *Conduct documentations to ensure the proper implementation of the project.*

2. The **Farmer Cooperator** shall:

- a. *Develop the farm to be a learning Site and tourist destination in the municipality and in the Province of Iloilo as a whole;*
- b. *Provide counterpart such as land, labor, other agri-inputs, animals and others;*
- c. *Share learning and technology to other farmers in the Province of Iloilo;*
- d. *Conduct regular monitoring and evaluation of the project;*
- e. *Submit to **Provincial Government of Iloilo** monthly status report of the project.*

NOW, THEREFORE, on motion of HON. NORBERTO T. TURALBA, Chairman, Committee on Agriculture and Aquatic Resources and duly seconded by Hon. Adrian S. Camporagrado, Hon. Neri T. Camiña, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Jerry T. Tuares, Hon. Joel L. Sayson and Hon. Ana Rowena A. Perera,

RESOLVED, to authorize Atty. Virgilio T. Teruel, Municipal Mayor, for and in behalf of the Municipality of Tigbauan to sign and enter into a Memorandum of Agreement (MOA) with the Iloilo Provincial Government, represented by Hon. Arthur R. Defensor, Jr., Governor on the Effective Implementation, Operation and Good Governance of the Integrated Farming System,

RESOLVED FURTHER, to furnish copies of this Resolution to the Office of the Municipal Mayor, Atty. Virgilio T. Teruel, to Hon. Arthur Defensor, Jr. and to all concerned for their information and/or appropriate action.
