Resolution No. 2023-137

ADOPTING THE INSTITUTIONALIZATION OF THE TIGBAW MONITORING AND EVALUATION SYSTEM [TIGBAW MES] IN THE MUNICIPALITY OF TIGBAUAN, ILOILO

WHEREAS, Section 7, Article V of Republic Act No. 11927, otherwise known as An Act to Enhance the Philippine Digital Workforce Competitiveness, Establishing for the purpose an Inter-agency Council for Development and Competitiveness of Philippine Digital Workforce and for other purposes, mandates that “all LGUs shall create local policies supporting and promoting the growth and development of digital technology”;

WHEREAS, the LGU envisioned to be the forefront of Technology by developing and adopting systems like Tigbauan Budgeting and Accounting Wizard [TIGBAW] and Project ISTAR which assisted in the budgeting and registry of Barangay Inhabitants;

WHEREAS, the apprentices of the 55th Batch Local Government Operations Officers have developed a system dubbed as TIGBAW-MES [Tigbaw Monitoring and Evaluation System] as a primary tool to be used by the Project Monitoring Committee [PMC] for monitoring and evaluating LGU-funded projects;

BE IT RESOLVED, as it is hereby resolved to recommend for the Institutionalization of the TIGBAW Monitoring and Evaluation System [Tigbaw MES] in the Municipality of Tigbauan, Iloilo;

RESOLVED FURTHER, that this resolution be an initial legislative measure to institutionalize the system into an ordinance;
