Resolution No. 2023- 182

RESOLUTION AUTHORIZING ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, ON BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO APPLY FOR A SPECIAL PATENT ON LOT NO. 8685-B, FOR THE ESTABLISHMENT OF TIGBAUAN MUNICIPAL ECO-TOURISM PARK;

WHEREAS, in a letter dated November 24, 2023, the Local Chief Executive requested this Sangguniang Bayan for the URGENT passing of the aforementioned Resolution;

WHEREAS, in view of a Deed of Definite Sale executed by the Clerk of Court and Ex-officio Provincial Sheriff, in favor of the Municipality of Tigbauan and ratified before Notary Public Renato D. Nuñez, LGU Tigbauan acquired *Lot No. 8685-B*, located at Barangay Supa, Tigbauan, Iloilo;

WHEREAS, since that time, the Municipal Government of Tigbauan has been the declared owner of Lot No. 8685-B, under Tax Declaration No. 40-0050-00266, with a total area of 11.1398 hectares;

WHEREAS, by virtue of Municipal Ordinance No. 2019-005, the Sangguniang Bayan of Tigbauan declared Lot No. 8685-B as the Municipal Eco-Tourism Park of Tigbauan, and a corresponding Comprehensive Development Plan was prepared therefore;

WHEREAS, Section 444 (vi) of the Local Government Code provides that "*the Chief Executive shall, upon authorization by the Sangguniang Bayan represent the municipality in all its business transactions and sign on its behalf all contracts and obligations, and such other documents made pursuant to law or ordinance*", but he/she may delegate some ministerial duties to some other persons upon proper authorization;

RESOLVED, to authorize Atty. Virgilio T. Teruel, Municipal Mayor, On Behalf Of The Municipality Of Tigbauan To Apply For A Special Patent on Lot No. 8685-B For the establishment of Tigbauan Municipal Eco-Tourism Park,
