RESOLUTION REQUESTING SENATOR CYNTHIA A. VILLAR FOR THE RIVERSIDE PROTECTION/ESPLANADE PROJECT ALONG THE SIBALOM RIVER, MUNICIPALITY OF TIGBAUAN, IN THE AMOUNT OF TWO HUNDRED MILLION PESOS (P200,000,000.00)

WHEREAS, the Municipality of Tigbauan has two (2) main rivers, the Sibalom River and Tacuyong River;

WHEREAS, the Sibalom River is the longest river in the Province of Antique, Island of Panay where it intersects with Tacuyong River before it reaches the shoreline between Barangay Parara Norte and Barangay 9, Poblacion of the Municipality of Tigbauan;

WHEREAS, the adjacent barangays along the Sibalom River are always affected by flooding and other calamities brought about by flood waters caused by heavy rains and typhoons;

WHEREAS, there is a need for adequate infrastructure projects that would protect lives and properties from dangers of flood waters and prevent erosion along the riverbanks of Barangays 1, 2, 3, 9 and Parara Norte;
