RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. VIRGILIO T. TERUEL, TO SIGN THE DEED OF DONATION (DOD) AND ACCEPTANCE WITH THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) FOR ONE (1) UNIT OF PATIENT TRANSPORT VEHICLE (PTV) UNDER ITS MEDICAL TRANSPORT VEHICLE DONATION PROGRAM

WHEREAS, in a letter dated January 12, 2024, the Local Chief Executive requested this Sangguniang Bayan for the URGENT passing of a *“Resolution Authorizing Atty. Virgilio T. Teruel, Municipal Mayor of Tigbauan, Iloilo, To Enter Into And Sign A Deed Of Donation (DOD) And Acceptance With The Philippine Charity Sweepstakes Office (PCSO) For One (1) Unit Of Patient Transport Vehicle (PTV) Under Its Medical Transport Vehicle Donation Program;*

WHEREAS, it is the declared policy of the state under Article II, Section 15 of the 1987 Philippine Constitution to protect and promote the right to health of the people;

WHEREAS, the Philippine Charity Sweepstakes Office (PCSO) is the principal government agency tasked to raise and provide funds for health programs, medical assistance and services, and charities of national character, and it is their thrust to ensure the provision and availability of medical facilities for emergency services, health care programs and social services to uplift the condition of the Filipino people;

WHEREAS, the Medical Transport Vehicle Donation Program of PCSO refers to the provision of medical transport vehicles to the Local Government Units at the provincial, municipal and city located in the conflict-stricken areas and vulnerable communities and those geographically-isolated and disadvantaged areas in order to immediately and safely transport the patients to, from, and between locations with most efficient access to places of treatment by land, water and areas of rough and mountainous terrain;

WHEREAS, the Local Government Unit of Tigbauan believes that the provision of one (1) unit Patient Transport Vehicle by the PCSO can be of great help in ensuring the efficient delivery of health services to the people;

NOW, THEREFORE, on motion of HON. ANA ROWENA A. PERERA, *Chairperson*, Committee on Health and Sanitation, and duly seconded by Hon. Neri T. Camiña, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares, Hon. Joel L. Sayson, Hon. Gaylord T. Trasporto and Hon. Florence Joy V. Cabalonga;

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Bayan to authorize the Municipal Mayor, Atty. Virgilio T. Teruel, to sign the deed of donation (DOD) and Acceptance with the Philippine Charity Sweepstakes Office (PCSO) for one (1) unit of Patient Transport Vehicle (PTV) under its medical transport vehicle donation program;
