RESOLUTION AUTHORIZING ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR OF TIGBAUAN, ILOILO, TO ENTER INTO AND SIGN A DEED OF DONATION (DOD) AND ACCEPTANCE WITH THE PHILIPPINE RICE RESEARCH INSTITUTE (PHILRICE-NEGROS) FOR 180 BAGS OF SEEDS UNDER THE RICE COMPETITIVENESS ENHANCEMENT FUND (RCEF)

WHEREAS, the Local Chief Executive in a letter dated January 26, 2024 requested this Sangguniang Bayan for the URGENT passing of the aforementioned Resolution;

WHEREAS, said **Deed of Donation (DOD)** shall be made and entered into by, and between the following parties:

- The Philippines Rice Research Institute (PhilRice-Negros), a chartered government corporate entity under the Department of Agriculture (DA), with office address at Cansilayan, Murcia, Negros Occidental and represented herein by its Branch Director, LEO T. STA. INES and hereinafter referred to as **"DONOR"** and
- The Local Government of Tigbauan, with office address at Municipal Hall, Tejero St., Tigbauan, Iloilo, represented herein by its Mayor, Atty. Virgilio T. Teruel and hereinafter referred to as **"DONEE"**.

WHEREAS, the DONOR is mandated to implement the development, propagation, and promotion of inbred rice quality seeds under the Rice Competitiveness Enhancement Fund (RCEF) in particular, provide certified Inbred seeds to help improve the competitiveness of the Filipino rice farmers, increase their income and sustain the resilience and responsiveness of the rice industry;

WHEREAS, the DONEE thru its Municipal Social Welfare Development Office (MSWDO) is mandated to address poverty-related concerns and implement different social welfare and development programs such as relief operations and feeding programs, and is committed to the care, protection and rehabilitation of individuals, families, groups and communities;

WHEREAS, the DONOR has undistributed seeds after farmers in certain municipalities opted to plant early or were catered to by the National Rice Program of the DA, and these seeds are no longer suitable as planting materials as shown by appropriate testing procedures; and

WHEREAS, the DONEE thru its MSWDO is very much willing to receive said undistributed rice seeds and mill the same in support of their program;

WHEREAS, in consideration of the aforementioned premises and their mutual covenants hereinafter set forth, the parties have agreed as follows:

1. That, for and in consideration of the aforesaid programs of the DONEE, the DONOR, by these presents, transfer, convey by way of donation, unto said DONEE, a total of 180 bags of seeds that are no longer suitable for planting, free from all liens and encumbrances;
2. That the DONEE does hereby accept this donation of 180 bags of seeds for the official use of MSWDO and hereby expresses gratitude for the kindness and generosity of the DONOR;
3. That the DONEE will arrange and shoulder the hauling from Brgy. Napnapan Norte Warehouse, Tigbauan, Iloilo and milling costs of the donated seeds.

NOW, THEREFORE, on motion of HON. NORBERTO T. TURALBA, Chairman, Committee on Agriculture and Aquatic Resources and duly seconded by Hon. Adrian S. Camposagrado, Hon. Neri T. Camiña, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Joel L. Sayson, Hon. Ana Rowena A. Perera, Hon. Gaylord T. Trasporto and Hon. Florence Joy V. Cabalonga,

RESOLVED, to Authorize Atty. Virgilio T. Teruel, Municipal Mayor of Tigbauan, Iloilo, to Enter Into and Sign a Deed of Donation (DOD) and Acceptance with the Philippine Rice Research Institute (PhilRice-Negros) for 180 Bags of seeds under the Rice Competitiveness Enhancement Fund (RCEF),

RESOLVED FURTHER, to furnish copies of this Resolution to Philippines Rice Research Institute (PhilRice-Negros) represented by its Branch Director, Leo T. Sta, Ines, to Atty. Virgilio T. Teruel, Municipal Mayor and all concerned for their information and/or appropriate action.
