RESOLUTION INTERPOSING NO OBJECTION TO THE REMOVAL/CUTTING OF THREE (3) MANGO TREES IN CONNECTION WITH THE ON-GOING CONSTRUCTION OF SIBALOM RIVER CONTROL (INCLUDING SHORELINE PROTECTION AND ACCESS ROAD) AT BARANGAY 1 POBLACION, TIGBAUAN, ILOILO.

WHEREAS, in a letter dated January 30, 2024, the Local Chief Executive requested this Sangguniang Bayan for the URGENT passing of this resolution;

WHEREAS, the Department of Public Works and Highways has been undertaking the construction of Sibalom River Control including Shoreline Protection and Access Road, Barangay 8 to Barangay 9, Tigbauan, Iloilo located at Barangay 1, Tigbauan, Iloilo;
