RESOLUTION ADOPTING PROVINCIAL ORDINANCE NO. 2019-195 ENTITLED, “EMPOWERMENT AND REAFFIRMATION OF PATERNAL ABILITIES (ERPAT) ORDINANCE OF THE PROVINCE OF ILOILO”

WHEREAS, Article II, Section 12 of the 1987 Philippine Constitution states that “The State recognizes the sanctity of family life and shall protect and strengthen the family as basic and autonomous social institution”;

WHEREAS, Article XV, Section 1 of the Philippine Constitution provides that, “The State recognizes the Filipino family as the foundation of the Nation and shall strengthen its solidarity and actively promote its total development”;

WHEREAS, Provincial Ordinance No. 2019-195, otherwise known as the Empowerment And Reaffirmation Of Paternal Abilities (ERPAT) Ordinance of the Province of Iloilo aims to enhance and strengthen the parenting capabilities of the Filipino fathers in performing their familial tasks and responsibilities, help them achieve and equal role with their spouses/partners in fostering the optimal development of their children and other family members and take leadership in the community in promoting positive family life;

WHEREAS, the ERPAT program provides learning opportunities for fathers to organize themselves and become partners of the Local Government Unit in the realizations of its programs and activities in the municipality;

WHEREAS, the adoption of the aforesaid ordinance will give importance and emphasis on the development and enrichment of knowledge, attitudes and skills of fathers in the Municipality of Tigbauan;
