RESOLUTION REQUESTING FOR ONE (1) UNIT OF FIRE TRUCK FROM THE SECRETARY OF THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT BENJAMIN “BENHUR” ABALOS JR. THROUGH THE PHILIPPINE COUNCILORS LEAGUE NATIONAL PRESIDENT HANDY LAO FOR THE MUNICIPALITY OF TIGBAUAN.

WHEREAS, by virtue of Presidential Proclamation No. 115-A, the month of March was declared as Fire Prevention Month because of the alarming increase of fire incidents happening across the country during this particular period;

WHEREAS, the Local Government Unit of Tigbauan is concerned of the increasing number of fire cases within its jurisdiction since January of Two Thousand Twenty Four up to the present;

WHEREAS, the Bureau of Fire Protection - Tigbauan has recorded a total of eight (8) residential and two (2) grass fire incidents in the municipality from February to March 2024 that affected an alarming number of families and households;

WHEREAS, alarmed by this record, the Local Government Unit aims to empower its disaster risk reduction and management team by upgrading its equipment and machineries to better improve its services;

WHEREAS, with this vision in mind, the Local Government Unit of Tigbauan is currently facing challenges as the existing resources and financial capability are lacking and insufficient;

NOW THEREFORE, on motion of HON. ADRIAN S. CAMPOSAGRADO, Chairman, Committee on Disaster, Risk Reduction and Management, Science and Technology and duly seconded by Hon. Neri T. Camiña, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares, Hon. Joel L. Sayson, Hon. Gaylord T. Trasporto and Hon. Florence Joy V. Cabalonga;

BE IT RESOLVED, as it is hereby resolved, to request one (1) unit of fire truck from the Secretary of the Department of Interior and Local Government Benjamin “Benhur” Abalos Jr. through the National President of the Philippine Councilors League Handy Lao for the Municipality of Tigbauan.

RESOLVED FURTHER, that this fire truck shall be used to boost the disaster risk reduction and management efforts of the Municipality of Tigbauan.

RESOLVED FINALLY, that copies of this resolution be furnished to the Office of the Secretary of the Department of Interior and Local Government Benjamin “Benhur” Abalos Jr., Office of the Philippine Councilors League National President Handy Lao, Office of the Philippine Councilors League - Iloilo President Ramon Sullano, and all other offices concerned for immediate and proper action.
