RESOLUTION GRANTING OMNIBUS AUTHORITY TO ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) FOR FINANCIAL ASSISTANCE/DONATIONS FROM THE SPECIAL EDUCATION FUND (SEF) AND GENERAL FUND FOR SCHOOLS, OTHER GOVERNMENT AGENCIES AND AUTHORIZED CIVIL SOCIETY ORGANIZATIONS (CSOS), SUBJECT TO STANDARD ACCOUNTING PROCEDURES FOR FISCAL YEAR 2024.

WHEREAS, the Municipality of Tigbauan has appropriated funds under its regular Annual Budget for the financial assistance/donations from Special Education Fund (SEF) and General Fund for schools, other government agencies and authorized Civil Society Organizations (CSOs) of this municipality;

WHEREAS, the different schools (*elementary, high schools and integrated schools*), other government agencies and authorized Civil Society Organizations (CSOs) of this municipality have requested funds/financial assistance for the implementation of their various projects from the Local Government Unit of Tigbauan;

WHEREAS, there is a need to authorize the Municipal Mayor, Atty. Virgilio T. Teruel, to enter into a Memorandum of Agreement with the different schools (*elementary, high schools and integrated schools*), other government agencies and authorized Civil Society Organizations (CSOs) in order that they could immediately effect the release/transfer of funds for their various projects;

WHEREAS, Section 444 (a), (b), (vi) of the Local Government Code provides among others, to wit:

SEC. 444. The Chief Executive: Powers, Duties, Functions and Compensation. - (a) The Municipal Mayor, as the chief executive of the municipal government, shall exercise such powers and perform such duties and functions as provided by this Code and other laws.

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

X X X

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, this omnibus authority to the Municipal Mayor covers the period of Fiscal Year 2024;

WHEREAS, through this grant of authority, the fast and efficient delivery of services will be ensured for the benefit and general welfare of the people of Tigbauan;

WHEREAS, to assure full transparency and accountability, the Local Chief Executive shall periodically update the local Sanggunian of the projects and programs that LGU-Tigbauan undertakes in partnership with the different schools (*elementary, high schools and integrated schools*), other government agencies and authorized Civil Society Organizations (CSOs), this municipality;


NOW, THEREFORE, on motion of HON. ADRIAN S. CAMPOSAGRADO, Chairman, Committee on Education, Tourism and Civil Service and duly seconded by Hon. Neri T. Camiña, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares, Hon. Gaylord T. Trasporto and Hon. Florence Joy V. Cabalonga;

BE IT RESOLVED, to grant Omnibus Authority to Honorable Atty. Virgilio T. Teruel, Municipal Mayor, for and in Behalf of the Municipality of Tigbauan to Sign and Enter Into A Memorandum of Agreement (MOA) for Financial Assistance/Donations from the Special Education Fund (SEF) and General Fund for Schools, Other Government Agencies and Authorized Civil Society Organizations (CSOs), Subject to Standard Accounting Procedures for Fiscal Year 2024;
