RESOLUTION GRANTING AUTHORITY TO ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, TO ENTER INTO A CONTRACT TO SELL/DEED OF ADJUDICATION WITH ABSOLUTE SALE WITH EDWARD S. TANGENTE AND EDZEL S. TANGENTE FOR THE PURCHASE OF A PORTION OF LOT NO. 1674, WITH AN AREA OF 1,553 SQUARE METERS, COVERED BY T.C.T. NO. 090-2019007460 LOCATED AT BRGY. 4 POBLACION, THIS MUNICIPALITY, AS ADDITIONAL AREA FOR THE NEW GOVERNMENT BUILDING WITH A TOTAL PURCHASE PRICE OF PHP 4,659,000.00

WHEREAS, Section 444 (vi) of the Local Government Code provides that, *“the Chief Executive shall, upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all contracts and obligations, and such other documents made pursuant to law or ordinance”*;

WHEREAS, the Local Government Unit of Tigbauan is in need to purchase an additional space/lot with an area of 1,553 square meters for the new government building at Barangay 4 Poblacion, Tigbauan, Iloilo;

WHEREAS, the Sangguniang Bayan has already approved Supplemental Budget and Annual Investment Plan (AIP) dated November 6, 2023 which included the purchase of additional Area (1,553 SQM) for the New Government Building at Barangay 4, (Pob.);

located at Brgy. 4 Poblacion, this municipality, as additional area for the New Government Building with a total purchase price of Php 4,659,000.00;
