RESOLUTION AUTHORIZING THE UPGRADE OF TIGBAUAN RURAL HEALTH UNIT AND NAMING IT AS TIGBAUAN PRIMARY CARE FACILITY WITH OFFICE ADDRESS AT TUPAN STREET, BARANGAY 5 POBLACION, TIGBAUAN, ILOILO

WHEREAS, it is the declared policy of the state under Article II, Section 15 of the 1987 Philippine Constitution to protect and promote the right to health of the people;

WHEREAS, Section 17(b)(2) of Republic Act 7160, otherwise known as the “*Local Government Code of 1991*” provides for the role of municipalities in the promotion of basic health services and facilities which includes access to secondary and tertiary health services, purchase of medicines, medical supplies, and equipment needed to carry out said services;

WHEREAS, Section 27(b) of the Universal Health Care Act (R.A. 11223) states that, “*the DOH shall institute a licensing and regulatory system for stand-alone health facilities, including those providing ambulatory and primary care services and other modes of health service provision*”;

WHEREAS, Department of Health (DOH) Administrative Order No. 2020-0047 dated September 30, 2020 provides for the rules and regulations governing the licensure of Primary Care Facilities (PCF) in the Philippines;

WHEREAS, as provided for in the above-mentioned A.O., a Primary Care Facility can either be government-owned or privately-owned, can be a rural health unit, urban health center, private medical, among others, and shall include the following as its ancillary services: clinical laboratory, diagnostic radiologic services, pharmacy, birthing services, dental services and ambulance service;

WHEREAS, in order to further improve the delivery of basic health services to its constituents, it is imperative to apply for license and to designate the Tigbauan Rural Health Unit as a Primary Care Facility in the municipality;

NOW THEREFORE, on motion of HON. JULIUS T. LEDESMA, Vice Chairman, Committee on Health and Sanitation and duly seconded by Hon. Adrian S. Camposagrado, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares, Hon. Joel L. Sayson and Hon. Gaylord T. Trasporto,

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Bayan to Authorize the upgrade of Tigbauan Rural Health Unit and name it as Tigbauan Primary Care Facility with office address at Tupan Street, Barangay 5 Poblacion, Tigbauan, Iloilo;

RESOLVED FURTHER, to furnish copies of this Resolution to the Office of the Municipal Mayor, Atty. Virgilio T. Teruel, to the Municipal Health Office, and to all concerned for their information and/or appropriate action.
