RESOLUTION AMENDING TEMPORARILY RULE VII, SECTION 14(b) OF RESOLUTION NO. 2022-083 OTHERWISE KNOWN AS THE INTERNAL RULES OF PROCEDURE OF THE SANGGUNIANG BAYAN OF TIGBAUAN, ILOILO, BY TRANSFERRING THE SESSION TIME ON MAY 2, 2024 18<sup>TH</sup> REGULAR SESSION FROM 9:00 O’CLOCK IN THE MORNING TO **8:00 O’CLOCK IN THE MORNING.**

WHEREAS, Rule VII, Section 14 par (b) of Resolution No. 2022-083 provides:

**“RULE VII – REGULAR AND SPECIAL SESSIONS**

**Section 14. REGULAR SESSION**

*(b.)The regular session shall be held every **Wednesday** and shall **start promptly at 9:00 in the morning.** Provided, however, that if the day falls on a holiday or the session is prevented by insuperable cause the next working day shall be the regular session day.*

WHEREAS, due to the seminar-workshop cum benchmarking of the Legislative and Executive Offices on May 2-5, 2024 at Bohol Province, the Members of the Sangguniang Bayan has decided (on consensus) to transfer the time of the regular session from 9:00 o’clock in the morning to **8:00 o’clock in the morning** to cope up with the scheduled flight at exactly 11:40 in the morning;
