RESOLUTION ADOPTING AND APPROVING MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 2024-03, DATED APRIL 17, 2024 “RESOLUTION APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) FOR THE PROCUREMENT OF HEAVY EQUIPMENT IN THE AMOUNT OF FIFTY MILLION PESOS (P50,000,000.00) TO BE SOURCED OUT FROM THE LOAN WITH LAND BANK OF THE PHILIPPINES”

WHEREAS, consistent to Section 297 of RA 7160 of the Local Government Code, the LGU may contract loan, credits and other forms of indebtedness with any government or domestic private bank and other lending institution to finance public infrastructure facilities or implementation of other capital investment projects, subject to such terms and conditions as may be agreed upon the lender;

WHEREAS, the Municipality of Tigbauan, Iloilo has a total farm-to-market roads of 88.89 kilometers of which 40 kilometers need immediate rehabilitation/repair and regular maintenance to make the roads accessible at all weather throughout the year in order to ensure that the movements and delivery of the agricultural products produced by the farmers in the far flung areas of the municipality to the center of trade will not be hampered, thus, acquisition of brand heavy equipment as enumerated is necessary and vital in the delivery of basic services in the far flung barangays;

WHEREAS, the total amount of Fifty Million Pesos (P50,000,000.00) to be sourced out from the loan with LBP is for the procurement of heavy equipment;


