RESOLUTION REQUESTING FROM THE OFFICE OF HON. FERDINAND MARTIN G. ROMUALDEZ, SPEAKER OF THE HOUSE OF REPRESENTATIVES, ONE (1) UNIT FIRE TRUCK FOR THE USE OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, by virtue of Presidential Proclamation No. 115-A, the month of March was declared as Fire Prevention Month because of the alarming increase of fire incidents happening across the country during this particular period;

WHEREAS, the Local Government Unit of Tigbauan is concerned of the increasing number of fire cases within its jurisdiction since January of Two Thousand Twenty Four up to the present;

WHEREAS, the Bureau of Fire Protection - Tigbauan has record a total of eight (8) residential and two (2) grass fire incidents in the municipality from February to March 2024 that affected an alarming number of families and households;

WHEREAS, alarmed by this record, the Local Government Unit aims to empower its disaster risk reduction and management team by upgrading its equipment and machineries to better improve its services;

WHEREAS, with this vision in mind, the Local Government Unit of Tigbauan is currently facing challenges as the existing resources and financial capability are lacking and insufficient;
