RESOLUTION GRANTING AUTHORITY TO ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PROVINCIAL LOCAL GOVERNMENT UNIT (PLGU) OF ILOILO AND THE FARMER-COOPERATOR OF TIGBAUAN, ILOILO IN CONNECTION WITH CORN SEED FARM PROJECT

WHEREAS, the said Memorandum of Agreement shall be made and entered into by, and between the following parties:

The Municipal Local Government of Tigbauan, Iloilo with principal address at 9 Poblacion, Tigbauan, Iloilo, represented herein by its Municipal Mayor, ATTY. VIRGILIO T. TERUEL, hereinafter referred to as the Municipal Local Government Unit (MLGU) of Tigbauan, Iloilo; and

ALBERT S. MAESTRECAMPO, with residence address at Barangay Namocon, Municipality of Tigbauan, Iloilo, herein referred to as the Farmer-Cooperator.

WHEREAS, the Provincial Agriculture Office, through its Corn Development Program aims to enhance the productivity level of corn farmers by utilizing high-quality seeds and adopting good agricultural practices in corn production;

WHEREAS, corn is the second most important crop in the country, a preferred main staple food at about 12 million Filipinos and comprises about 70% of livestock mixed feed;

WHEREAS, corn in Iloilo become an emerging crop as the main source of livelihood for many small-scale farmers;

WHEREAS, there is a high demand for corn as a main ingredient for animal feeds and as corn-based products;

WHEREAS, to address the increasing demand for supply, the provision of corn seeds to farmers is recommended:

WHEREAS, the Provincial Agriculture Office will establish a Corn Seed Farm for seed production as one of the sources to provide farmers good quality seeds;

WHEREAS, for and in consideration of the foregoing premises and their mutual covenants hereafter set forth, the parties agree to join hands to undertake this project on the following terms and conditions:

ARTICLE 1 TITLE AND DESCRIPTION OF THE PROJECT

The Corn Seed Farm is a project that produces good quality seeds using the Open-Pollinated Variety (OPV Corn Yellow) and distributes them to interested corn farmers of the Province of Iloilo.

ARTICLE II RESPONSIBILITIES OF THE PARTIES

A. The PLGU shall:

- 1. Provide inputs/materials/tools in the establishment of a corn seed farm.
- 2. Provide orientation/briefing to farmer-cooperator in the establishment of corn seed farm.
- 3. Supervise/Provide technical assistance to the farmer-cooperator in the establishment of the project.
- 4. Monitoring/Documentation of the project implementation.
- 5. Collect payback corn seeds form the farmer-cooperator.
- 6. Disperse/redisperse corn seeds returned by the farmer-cooperator to other interested farmers.

B. The MLGU shall:

- 1. Identify/Certify that the farmer-cooperator is registered under RSBSA and engaged in corn farmina.
- 2. Assist/Provide technical assistance to the farmer-cooperator in the establishment of the project.
- 3. Assist in the collection of payback corn seeds.
- 4. Assist in the monitoring/documentation of the project.

C. The FARMER-COOPERATOR shall:

- 1. Provide land; labor and facilities as their counterpart.
- 2. Agree to implement the management practices/new technologies on corn production.
- 3. Keep a record of farm activities with corresponding costs.
- 4. Share his/her technologies learned with other farmers.
- 5. Agree to pay back the received inputs/materials in the form of corn seeds for dispersal to other interested corn farmers.

NOW, THEREFORE, on motion of HON. NORBERTO T. TURALBA, Chairman, Committee on Agriculture and Aquatic Resources, and duly seconded by Hon. Adrian S. Camposagrado, Hon. Neri T. Camiña, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Jerry T. Tuares, Hon. Gaylord T. Trasporto and Hon. Florence Joy V. Cabalonga,

RESOLVED, to Grant Authority to Atty. Virgilio T. Teruel, Municipal Mayor, for and in behalf of the Municipality of Tigbauan, to Sign and Enter Into A Memorandum of Agreement (MOA) with the Provincial Local Government Unit (PLGU) of Iloilo and the Farmer-Cooperator of Tigbauan, Iloilo in connection with Corn Seed Farm Project,
