RESOLUTION GRANTING AUTHORITY TO ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, TO NEGOTIATE WITH EDWARD S. TANGENTE AND EDZEL S. TANGENTE FOR THE PURCHASE OF A PORTION OF LOT NO. 1674 WITH AN AREA OF 554 SQUARE METERS, MORE OR LESS, COVERED BY T.C.T. NO. 090-2019007460 LOCATED AT BRGYS. 4 POBLACION, THIS MUNICIPALITY AS ADDITIONAL AREA FOR THE NEW GOVERNMENT BUILDING WITH A TOTAL PURCHASE PRICE OF PHP 1,632,000.00 AND TO SIGN ANY AND ALL DOCUMENTS IN CONNECTION THERETO

WHEREAS, Section 444 (vi) of the Local Government Code provides that, *“the Chief Executive shall, upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all contracts and obligations, and such other documents made pursuant to law or ordinance”*;

WHEREAS, the Local Government Unit of Tigbauan is in need to purchase of a portion of Lot No. 1674 with an area of 554 square meters as an additional area for the new government building situated at Barangay 4, Poblacion, Tigbauan, Iloilo;

WHEREAS, the Sangguniang Bayan has already approved Supplemental Budget and Annual Investment Plan (AIP) dated November 6, 2023 which included the purchase of additional Area (554 SQM) for the New Government Building at Barangay 4, (Pob.) which is a continuing Appropriation for 2024;

RESOLVED, to grant Authority to Atty. Virgilio T. Teruel, Municipal Mayor, for and in behalf of the Municipality of Tigbauan, to negotiate with Edward S. Tangente and Edzel S. Tangente for the Purchase of a Portion of Lot No. 1674 with an area of 554 square meters, more or less, covered by T.C.T. No. 090-2019007460 located at Brgys. 4 Poblacion, this Municipality as additional area for the new Government Building with a total purchase price of Php 1,632,000.00 and to sign any and all Documents in connection thereto,
