RESOLUTION GRANTING AUTHORITY TO ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR,. FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, TO APPLY FOR A CERTIFICATE OF NON-IRRIGATION COVERAGE (CNIC)/CERTIFICATE OF IRRIGATION COVERAGE (CIC) FROM THE NATIONAL IRRIGATION ADMINISTRATION (NIA) FOR THE PARCEL OF LAND KNOWN AS LOT NO. 1673-A, LOCATED AT BARANGAY 4 POBLACION, TIGBAUAN, ILOILO, WHEREIN A NEW GOVERNMENT CENTER WILL BE CONSTRUCTED

WHEREAS, this authority is one of the primary requirements to apply for a Certificate Of Non-Irrigation Coverage (CNIC)/Certificate Of Irrigation Coverage (CIC) from the National Irrigation Administration (NIA) for the on-going construction of the new Municipal Building;

WHEREAS, the location of the project is within the service area of Sibalom River Irrigation System, located at Brgy. 4 Poblacion, Tigbauan, Iloilo;

Teruel, Municipal Mayor, for and in behalf of the Municipality of Tigbauan, to apply for a Certificate of Non-Irrigation Coverage (CNIC)/Certificate of Irrigation Coverage (CIC) from the National Irrigation Administration (NIA) for the Parcel of Land known as Lot No. 1673-A, located at Barangay 4 Poblacion, Tigbauan, Iloilo, wherein a new government center will be constructed.
