RESOLUTION GRANTING AUTHORITY TO ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, TO SIGN AND ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE COMMISSION ON POPULATION AND DEVELOPMENT-REGION VI (CPD-REGION VI) FOR THE LOCALIZATION STRATEGY OF THE PHILIPPINE POPULATION AND DEVELOPMENT-PLAN OF ACTION (PPD-POA) 2023-2028

WHEREAS, the Philippine Development Plan (PDP) 2023-2028 recognizes the role of the country’s demographic condition in increasing its capacity to bring back the country to a high-growth trajectory and enable economic and social transformation for a prosperous, inclusive and resilient society;

WHEREAS, Memorandum Circular No. 40 dated November 14, 2023 issued by President Ferdinand R. Marcos, Jr. approved and adopted the Philippine Population and Development-Plan of Action (PPD-POA) 2023-2028, and directing the implementation thereof;

WHEREAS, the Commission on Population and Development (CPD) is the government agency mandated to be the central policy-making, planning, coordinating, and monitoring body of the Philippine Population and Development-Plan of Action (PPD-POA) that is being implemented at the local government units;

WHEREAS, with the full devolution of the provision of basic services and facilities to the LGUs as per Executive Order No. 138 and Mandanas-Garcia Ruling, national government agencies can assume more strategic and steering functions to address persistent development issues;

WHEREAS, Section 3 of RA No. 7160 provides the operative principles of decentralization that shall guide the formulation of policies and measures on local autonomy;

WHEREAS, the Local Government Code devolved to the LGUs the primary responsibility of attaining and ensuring the welfare and development of its people and their localities through the provision of appropriate services including population and family planning services;

WHEREAS, Local Government Code (LGC) of 1991, Section 25 (b) states: *“National agencies and offices with project implementation functions shall coordinate with one another and with the LGUs concerned in the discharge of these functions. They shall ensure the participation of LGUs both in the planning and implementation of said national projects.”*

WHEREAS, the Local Budget Memorandum No. 85-A of the Department of Budget and Management states: The delivery of social welfare services, specifically population development services, shall be part of the functions and services that shall be devolved by the Commission on Population and Development (CPD);

WHEREAS, as an emerging national concern and as part of the priority issues of the PPD-POA 2023-2028, there is an urgent need for all government agencies at all levels to take action to reduce the increasing incidence of early pregnancies among adolescents and gap between wanted and actual fertility among women and couples of reproductive age;

WHEREAS, for and in consideration of the foregoing premises, hereinafter set forth, the PARTIES hereby agree as follows:

Section 2: ROLES AND RESPONSIBILITIES OF THE PARTIES

1. The CPD-REGION VI:

To support the MUNICIPALITY OF **TIGBAUAN**, the CPD-REGION VI shall:

- 1.1 Provide technical assistance to the MUNICIPALITY OF TIGBAUAN in the attainment of the mutual objectives of the MOU;*
- 1.2 Collaborate with the LGU in assessing and capacity building interventions in improving the competencies of staff and leaders involved in the planning, implementation, monitoring and evaluation of local POPDEV strategies; and*
- 1.3 Provide timely coaching and mentoring to concerned local leaders and managers in pursuing POPDEV strategies.*

2. The MUNICIPALITY OF TIGBAUAN shall:

- 2.1 Strive to pursue the mutual objectives of the MOU through mobilization and active engagement of relevant local structures and offices and allocation of needed resources;*
- 2.2 Pursue sustainability of POPDEV strategies and interventions through, but not limited to, integration of such strategies in the local development plans and investment program;*
- 2.3 Monitor and evaluate the results of POPDEV strategies for enhancement; and*
- 2.4 Create or facilitate participation of civil society organizations, people organizations, development partners and other relevant institutions to foster participatory program implementation;*

NOW, THEREFORE, on motion of HON. JULIUS T. LEDESMA and duly seconded by Hon. Neri T. Camiña, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares, Hon. Joel L. Sayson and Hon. Florence Joy V. Cabalonga;

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Bayan to Grant Authority to Atty. Virgilio T. Teruel, Municipal Mayor, for and in behalf of the Municipality of Tigbauan, to sign and enter into a Memorandum of Understanding (MOU) with the Commission on Population and Development-Region VI (CPD-REGION VI) for the Localization Strategy of the Philippine Population and Development- Plan of Action (PPD-POA) 2023-2028;

RESOLVED FURTHER, to furnish copies of this Resolution to the Office of the Municipal Mayor, to the Local Population Office, and to all concerned for their information and/or appropriate action.
