RESOLUTION CONFORMING AND APPROVING THE CY 2024 SK ANNUAL BUDGET OF BARANGAYS ALUPIDIAN, BAGUMBAYAN, 2 POBLACION, 9 POBLACION, BAROSONG, BARROC, DAPDAP, DORONG-AN, GUISIAN, ISAUAN, PARARA NORTE AND SAN RAFAEL, ALL OF THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on May 21, 2024 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the CY 2024 SK Annual Budget of the aforementioned Barangays, to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace:

*The appropriation of **Brgy. Alupidian** for the SK Annual Budget CY 2024 in the amount of **P225,500.00** shall be utilized for the following expenditures: General Administrative Program – P121,675.00 and SK Development Empowerment Program – P103,825.00*

*The appropriation of **Brgy. Bagumbayan** for the SK Annual Budget CY 2024 in the amount of **P398,000.00** shall be utilized for the following expenditures: General Administrative Program- P160,300.00 and SK Development Empowerment Program – P237,700.00.*

*The appropriation of **Brgy. 2 Poblacion** for the SK Annual Budget CY 2024 in the amount of **P297,000.00** shall be utilized for the following expenditures: General Administrative Program - P157,450.00 and SK Development Empowerment Program - P139,550.00.*

*The appropriation of **Brgy. 9 Poblacion** for the SK Annual Budget CY 2024 in the amount of **P308,000.00** shall be utilized for the following expenditures: General Administrative Program- P173,300 and SK Development Empowerment Program- P129,700.00.*

*The appropriation of **Brgy. Barosong** for the SK Annual Budget CY 2024 in the amount of **P327,000.00** shall be utilized for the following expenditures: General Administrative Program - P210,450.00 and SK Development Empowerment Program - P116,550.00.*

*The appropriation of **Brgy. Barroc** for the SK Annual Budget CY 2024 in the amount of **P430,000.00** shall be utilized for the following expenditures: General Administrative Program - P198,500.00 and SK Development Empowerment Program - P231,500.00.*

*The appropriation of **Brgy. Dapdap** for the SK Annual Budget CY 2024 in the amount of **P260,000.00** shall be utilized for the following expenditures: General Administrative Program- P142,000.00 and SK Development Empowerment Program - P118,000.00.*

*The appropriation of **Brgy. Dorong-an** for the SK Annual Budget CY 2024 in the amount of **P456,000.00** shall be utilized for the following expenditures: General Administrative Program - P300,600.00 and SK Development Empowerment Program- P155,400.00.*

The appropriation of **Brgy. Guisian** for the SK Annual Budget CY 2024 in the amount of **P218,,000.00** shall be utilized for the following expenditures: General Administrative Program - P117,800.00 and SK Development Empowerment Program- P100,200.00.

The appropriation of **Brgy. Isauan** for the SK Annual Budget CY 2024 in the amount of **P220,000.00** shall be utilized for the following expenditures: General Administrative Program - P130,000.00 and SK Development Empowerment Program- P90,000.00.

The appropriation of **Brgy. Parara Norte** for the SK Annual Budget CY 2024 in the amount of **P434,500.00** shall be utilized for the following expenditures: General Administrative Program- P273,325.00 and SK Development Empowerment Program – P161,175.00.

The appropriation of **Brgy. San Rafael** for the SK Annual Budget CY 2024 in the amount of **P224,000.00** shall be utilized for the following expenditures: General Administrative Program- P145,900.00 and SK Development Empowerment Program – P78,100.00.
