**Resolution No. 2024-070**

RESOLUTION ADOPTING THE PEACE AND ORDER AND PUBLIC SAFETY (POPS) PLAN FOR 2023-2025 OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, Section 116 of Republic Act 7160, otherwise known as the Local Government Code of 1991 mandates for the establishment of the Local Peace and Order Council in every province, city and municipality;
