RESOLUTION ADOPTING THE PEACE AND ORDER AND PUBLIC SAFETY (POPS) PLAN FOR 2023-2025 OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, Section 116 of Republic Act 7160, otherwise known as the Local Government Code of 1991 mandates for the establishment of the Local Peace and Order Council in every province, city and municipality;

WHEREAS, the Department of the Interior and Local Government (DILG) issued Memorandum Circular No. 2015-130 dated November 3, 2015 which specifically mandates for the formulation of a three-year Local Peace and Order and Public Safety (POPS) Plan to be incorporated in the Comprehensive Development Plan of the concerned Local Government Unit;

WHEREAS, in compliance to such mandate, the Municipal Peace and Order Council (MPOC) formulated the Peace and Order and Public Safety Plan of the Municipality of Tigbauan for 2023-2025;

WHEREAS, the Sanggunian finds the importance of the POPS Plan for 2023-2025 as it will serve as a continuous guide in the implementation of peace and order programs of the Local Government Unit of Tigbauan, thus, adoption is considered;
