RESOLUTION REQUESTING FOR VARIOUS IT EQUIPMENT FROM THE OFFICE OF BOARD MEMBER, HON. MARCELO VALENTINE S. SERAG TO BE USED BY THE ENERGY EFFICIENCY AND CONSERVATION OFFICE (EECO) OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, Section 7 of RA 11285, also known as “*Energy Efficiency and Conservation Act*” provides for the role of LGUs to establish their respective EECOs headed by an EEC Officer as defined in Section 4(l) and (m) of the said Act;

WHEREAS, one of the responsibilities of the EEC Officer is to comply with the use of Government Energy Management Program(GEMP) System to record all required data by the Department of Energy. It accepts and keeps information of all building, facilities, vehicles and equipment of the LGUs that consume energy in particular, electricity and fuel;

WHEREAS, the recorded data may then be used as basis for formulating various PPAs that aims to reduce energy consumption by 10%. The GEMP system is currently used in one of the desktops of the General Services Office. All files and documents of EECO are also saved in this computer;

WHEREAS, in order to prevent document and files from getting mixed up and to ensure efficiency in data management. It is best that the EECO has its dedicated IT Equipment only for EECO related tasks. It is on this premise that we plan to request for preferably high end one (1) unit laptop, one (1) unit Desktop Computer, and one (1) unit 3-in-1 printer/scanner which will be used exclusively by the EEC Office of this municipality;
