**Resolution No. 2024-079**

RESOLUTION GRANTING AUTHORITY TO ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH **JEO CONSTRUCTION SUPPLY (HARDWARE, CONSTRUCTION & ELECTRICAL SUPPLY)** IN ORDER TO FORGE PARTNERSHIPS IN RELATION TO THE PROTECTION AND PRESERVATION OF LIFE AND PROPERTIES DURING CALAMITIES AND/OR EMERGENCIES.

**WHEREAS**, the Local Chief Executive in a letter dated June 3, 2024 requested this Sangguniang Bayan for the URGENT passing of the aforementioned resolution;

**WHEREAS**, said **Memorandum of Agreement** shall be made and entered into by, and between the following parties:

- The **MUNICIPAL GOVERNMENT OF TIGBAUAN, ILOILO** a local government unit, with seat of government at the Tigbauan Municipal Hall, Barangay Poblacion 9, Tigbauan, Iloilo represented by its Municipal Mayor, **ATTY. VIRGILIO T. TERUEL**, as **“FIRST PARTY”**;
- The **HARDWARE, CONSTRUCTION AND ELECTRICAL SUPPLY**, an organization with principal address at Iloilo Province, Philippines represented by its Owner, Mr. Jeo Torrato as **“SECOND PARTY”**;

**WHEREAS**, the **FIRST PARTY** is mandated under the **“REPUBLIC ACT 10121”** or the Philippine Disaster Risk Reduction and Management Act of 2010, to develop, strengthen and operationalize mechanisms for partnerships or networking with the private sector;

**WHEREAS**, said Act states that the Local Disaster Risk Reduction and Management Offices (LDRRMOs) may mobilize instrumentalities and entities in the protection and preservation of life and properties during calamities and/ or emergencies in accordance with existing policies and procedures;

**WHEREAS**, LDRRMOs shall respond to and manage the adverse effects of emergencies and carry out recovery activities in affected areas within their jurisdiction ensuring that there is an efficient mechanism for immediate delivery of food, shelter and medical supplies especially for older people, women, children and person with disability;

**WHEREAS**, the private sector including but not limited to private corporations, business, households and non-profit organizations being stakeholders and drivers of the community’s economy shall be tapped and / or mobilized in times of calamities and / or emergencies;

**WHEREAS**, in undertaking pre-disaster actions and measures within the context of disaster risk reduction and management, it is best to have an agreement with relevant entities to ensure availability and continuity of basic goods and services respectively;

**WHEREAS**, for and in consideration of the foregoing premises, the PARTIES hereby agree as follows:

- 1. The **FIRST PARTY** and the **SECOND PARTY** hereby agree to cooperate and coordinate in accordance with **REPUBLIC ACT 10121** or the **Philippine Disaster Risk Reduction and Management Act of 2010** during emergencies for the protection and preservation of life and properties;
- 2. The **SECOND PARTY** has an existing partnership with the Local Government of Tigbauan to provide and augment on construction and builders supplies including, but are not limited to cleaning compounds, lubricants, grinding wheels, hacksaw blades, sandpaper, tarpaulins, and rope, hinges, locks, doors, fasteners, windows, exit devices, and security devices, as well as electrical supplies in times of calamities and uncertainties.


**NOW, THEREFORE**, on motion of **HON. ADRIAN S. CAMPOSAGRADO**, Chairman, Committee on Disaster, Risk Reduction and Management, Science and Technology and duly seconded by Hon. Neri T. Camiña, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares, Hon. Ana Rowena A. Perera, Hon. Gaylord T. Trasporto Hon. Florence Joy Cabalonga;

**RESOLVED**, to grant Authority to Atty. Virgilio T. Teruel, Municipal Mayor, for and in Behalf of the Municipality of Tigbauan, to Sign and Enter Into A Memorandum of Agreement (MOA) With **Jeo Construction Supply (Hardware, Construction & Electrical Supply)** in Order to Forge Partnerships in Relation to the Protection and Preservation of Life and Properties During Calamities and/or Emergencies;
