**Resolution No. 2024-087**

RESOLUTION ADOPTING THE PHILIPPINE PLAN OF ACTION FOR NUTRITION (PPAN) 2023-2028 FOR LOCAL IMPLEMENTATION IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, Article XV, Section 3 of the 1987 Philippine Constitution mandates that, *“the State shall defend the rights of children to assistance, including proper care and nutrition”*;

WHEREAS, Malnutrition is still a prevailing problem in the country with high rates of stunting, wasting, micro-nutrient deficiencies and increasing trend in overweight and obesity;

WHEREAS, to effectively address the alarming levels of malnutrition in the country, the National Nutrition Council (NNC), in consultation with various stakeholders from national government agencies (NGAs), local government units (LGUs), non-government organizations (NGOs), development partners, and academic institutions, formulated and approved the Philippine Plan of Action for Nutrition (PPAN) 2020-2028 on July 12, 2023;

WHEREAS, the Department of the Interior and Local Government (DILG) issued Memorandum Circular No. 2024-071 dated May 10, 2024 which provides for the guidelines on the roles and responsibilities of DILG Offices and Local Government Units (LGUs) on the implementation of the Philippine Plan of Action for Nutrition (PPAN) 2023-2028;

WHEREAS, the PPAN 2023-2028 is aligned with the directions set in the thematic chapters of the Philippine Development Plan 2023-2028;
