RESOLUTION GRANTING AUTHORITY TO ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE TUBUNGAN PRIMARY HEALTH FACILITY IN CONNECTION WITH ITS LABORATORY FACILITY/SERVICES

WHEREAS, in a letter dated June 11, 2024, the Local Chief Executive requested this Sangguniang Bayan for the URGENT passing of a *“Resolution Granting Authority To Atty. Virgilio T. Teruel, Municipal Mayor, For And In Behalf Of The Municipality Of Tigbauan To Sign And Enter Into A Memorandum Of Agreement (MOA) With The Tubungan Primary Health Facility In Connection With Its Laboratory Facility/Services”*

WHEREAS, the said **Memorandum of Agreement** shall be made and entered into by, and between the following parties:

- The **MUNICIPALITY OF TIGBAUAN**, with address at Barangay 9 Poblacion Tigbauan, Iloilo, herein represented by its **MUNICIPAL MAYOR, ATTY. VIRGILIO T. TERUEL**, and hereinafter referred to as the **“REFERRING PARTY”**; and
- The **TUBUNGAN PRIMARY HEALTH FACILITY**, a government-owned health center located at Tubungan, Iloilo, herein represented by its **MUNICIPAL MAYOR, ROQUITO G. TACSAGON**, and hereinafter referred to as the **“TUBUNGAN PRIMARY HEALTH FACILITY”**;

WHEREAS, Section 11, Article XIII of the 1987 Constitution declared that, *“The state shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health, and other social services available to all people at an affordable cost. There shall be a priority for the needs of the underprivileged, sick, elderly, disabled, women, and children.”*

WHEREAS, Section 444 (b)(1)(vi) of the Local Government Code provides that, *“the Chief Executive shall, upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all contracts and obligations, and such other documents made pursuant to law or ordinance”*;

WHEREAS, there is a need to establish a partnership and referral system with other health service providers/facilities duly accredited by the Department of Health in order to improve the delivery of quality health care to patients;

WHEREAS, for and in consideration of the foregoing premises, the parties agree to undertake the program under the following terms and conditions:

1. SERVICES

The TUBUNGAN PRIMARY HEALTH FACILITY shall:

- 1.1 Make available the laboratory services of TUBUNGAN PRIMARY HEALTH FACILITY as required by the REFERRING PARTY. To facilitate the service, the REFERRING PARTY shall allow the TUBUNGAN PRIMARY HEALTH FACILITY to extract samples in the facility of the REFERRING PARTY; and*
- 1.2 Immediately upon receipt of the specimen, shall inspect the same, and reserve the right to either accept or reject it, indicating reasons for the rejection. The REFERRING PARTY shall be notified of the rejection and shall be requested to re-collect the rejected specimen.*

2. COLLECTION OF SPECIMEN

2.1 It shall be responsibility of the TUBUNGAN PRIMARY HEALTH FACILITY to:

- 2.1.1 Ensure that proper care is observed to ensure the validity of the specimens;*
- 2.1.2 Ensure that the collection and handling of specimens strictly follow the required guidelines duly recognized and prescribed for specimen collection and handling; and*
- 2.1.3 Ensure that biological specimens are collected in the appropriate container and properly labeled.*

2.2 The REFERRING PARTY shall be solely responsible for the correct and proper patient preparation, specimen collection, packaging and transport. In case of rejection of specimen, the REFERRING LABORATORY shall accept the return of said rejected specimen.

3. RESULTS-

3.1 The TUBUNGAN PRIMARY HEALTH FACILITY shall:

- 3.1.1 Release the medical results only to designated representatives of the REFERRING PARTY within one (1) working day for routine tests/procedures after diagnostic service is conducted. However, tests with running days shall be delivered as soon as the results become available. Results can be requested to be transmitted via facsimile or email;*
- 3.1.2 At all times, endeavor and exert its best efforts to deliver accurate, reliable and timely results based on the specimen submitted in compliance with the correct patient preparation, specimen collection, packaging and transport procedure to be duly observed by the REFERRING PARTY.*

3.2 The REFERRING PARTY shall be responsible for transmitting the results to attending physicians and patients. It is understood and agreed that the TUBUNGAN PRIMARY HEALTH FACILITY's obligation is to the REFERRING PARTY and is not obliged to deal with the patient and/or attending physician.

NOW, THEREFORE, on motion of HON. ANA ROWENA A. PERERA, *Chairperson*, Committee on Health and Sanitation, and duly seconded by Hon. Adrian S. Camposagrado, Hon. Neri T. Camiña, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares, Hon. Joel L. Sayson, Hon. Gaylord T. Trasporto and Hon. Florence Joy V. Cabalonga;

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Bayan to Grant Authority to Atty. Virgilio T. Teruel, Municipal Mayor, for and in behalf of the Municipality of Tigbauan to sign and enter into a Memorandum of Agreement (MOA) with the Tubungan Primary Health Facility in connection with its Laboratory Facility/Services”;

RESOLVED FURTHER, to furnish copies of this Resolution to the Office of the Municipal Mayor, to the Municipal Health Office, and to all concerned for their information and/or appropriate action.
