RESOLUTION CONFORMING AND APPROVING THE CY 2024 SK ANNUAL BUDGET OF BARANGAYS CORDOVA SUR, SERMON AND SIPITAN OF THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on June 13, 2024 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the CY 2024 SK Annual Budget of the aforementioned Barangays, this municipality to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace;_

*The appropriation of **Brgy. Cordova Sur** for the SK Annual Budget CY 2024 in the amount of **P341,500.00** shall be utilized for the following expenditures: General Administrative Program - P161,275.00 and SK Development Empowerment Program - P180,225.00;*

*The appropriation of **Brgy. Sermon** for the SK Annual Budget CY 2024 in the amount of **P222,000.00** shall be utilized for the following expenditures: General Administrative Program- P135,700.00 and SK Development Empowerment Program - P86,300.00.*

*The appropriation of **Brgy. Sipitan** for the SK Annual Budget CY 2024 in the amount of **P242,000.00** shall be utilized for the following expenditures: General Administrative Program - P130,700.00 and SK Development Empowerment Program - P111,300.00.*

WHEREAS, the Municipal Budget Officer had reviewed in advance and endorsed to this August Body the SK Annual Budget which show apparent compliance with the provisions of the 1991 Local Government Code and its Implementing Rules and Regulations;

WHEREAS, the review of the foregoing documents/budgets likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;
