RESOLUTION AMENDING RESOLUTION NO. 2024-001- “RESOLUTION REORGANIZING THE COMPOSITION OF THE DIFFERENT S.B. STANDING COMMITTEES OF THE SANGGUNIANG BAYAN, TIGBAUAN, ILOILO” TO ELECT HON. GAYLORD TRASPORTO AS THE NEW CHAIRMAN OF THE COMMITTEE ON INFRASTRUCTURE AND GENERAL SERVICES.

WHEREAS, consistent with the declared policy of Republic Act 7160 otherwise known as the Local Government Code of 1991, *the Sangguniang Bayan (S.B.) is a structure of Local Government that should be “.....more responsive and accountable” to the people whom we serve;*

WHEREAS, Hon. Neri T. Camiña, Chairman, Committee on Infrastructure and General Services tendered his irrevocable resignation last June 13, 2024 S.B.’s Regular Session under item Privilege Speech;

WHEREAS, through a unanimous vote on June 26, 2024, Hon. Gaylord Trasporto has been elected by the members of the Sangguniang Bayan as the new chairman of the Committee on Infrastructure and General Services;

WHEREAS, reorganizing the composition of these Standing Committees can immediately delineate to the newly elected Chairman his tasks and responsibilities in order that the delivery of basic services will not be hampered;

WHEREAS, the power to pass local legislation also carries with it the power to monitor their faithful compliance and meaningful execution;
