RESOLUTION CONFORMING AND ADOPTING THE SUPPLEMENTAL INVESTMENT PROGRAM (AIP) SUPPLEMENTING THE PERSONAL SERVICES (PS) COSTS FOR THE CREATION OF NEW POSITIONS EFFECTIVE JULY 1, 2024, GRANT OF NEW RATA RATES TO OFFICIALS OF LOCAL GOVERNMENT UNITS (LGUs) FOR FY 2024 AND YEARS THEREAFTER RETROACTIVE FROM JANUARY 2024, IMPLEMENTATION OF INCREASE IN THE PAG-IBIG CONTRIBUTIONS STARTING FEBRUARY 2024, PAYMENT OF TERMINAL LEAVE BENEFITS AND MONETIZATION OF LEAVE CREDITS AND OTHER PS FUNDS WITH THE TOTAL AMOUNT EIGHT MILLION FIVE HUNDRED EIGHTY-ONE THOUSAND PESOS (P8,581,000.00) OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO."
