RESOLUTION RECOGNIZING THE SCHOOL-BASED MULTI-PURPOSE TEEN CENTERS OF TIGBAUAN NATIONAL HIGH SCHOOL, CORDOVA NATIONAL HIGH SCHOOL AND PARARA NATIONAL HIGH SCHOOL IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, Section 2(b) of Republic Act (RA) No. 8044 otherwise known as the "Youth in Nation Building Act" provides that "Youth" is the critical period in a person's growth and development from the onset of adolescence towards the peak of mature, self-reliant and responsible adulthood comprising the considerable sector of the population from the age of fifteen (15) to thirty (30) years;

WHEREAS, the establishment of Teen Centers within local government units (LGUs) is intended to create a specifically designed space and allocate resources specifically for the growth and welfare of teenagers. The LGU seeks to cultivate a safe and enabling environment through the establishment of these centers, fostering empowerment, personal growth and development, as well as active involvement among the youth;

WHEREAS, Section 56(c) of Municipal Ordinance No. 2019-012, otherwise known as the Child and Youth Welfare Development Code of the Municipality of Tigbauan, Province of Iloilo, provides that, "Intervention and Delinquency Prevention – Each LGU shall establish programs CICL (child in conflict with the law) or CAR (child at risk) intervention and delinquency prevention to address issues that cause the child to commit an offense, taking into consideration the following x x x (c) Provision of local counterpart for the establishment of school-based/community-based teen center x x x";

WHEREAS, further, in pursuant to Sangguniang Bayan Resolution No. 2021-042, former Mayor Alquisada was also authorized, for and in behalf of the Municipality of Tigbauan, to enter into Memorandum of Agreement (MOA) with the Iloilo Provincial Government, Cordova National High School and Parara National High School, the Liga ng mga Barangay of Tigbauan and the Sangguniang Kabataan for the establishment of additional school-based multi-purpose teen centers;
