RESOLUTION CONFORMING AND APPROVING THE CY 2024 SK ANNUAL BUDGET OF BARANGAY CANABUAN OF THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on July 3, 2024 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the CY 2024 SK Annual Budget of Barangay Canabuan to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace:
