Resolution No. 2024-109

RESOLUTION DECLARING AS **LEGAL** AND **VALID** BARANGAY 9 (POBLACION), TIGBAUAN, ILOILO **ORDINANCE NO. 2024-005** – “AN ORDINANCE PROHIBITING AND REMOVING ANY OBJECT CAUSING OBSTRUCTION/S ON STREETS, SIDEWALKS, ALLEYS, PARKS AND OTHER SIMILAR PUBLIC PLACES WITHIN THE AREA OF JURISDICTION OF BARANGAY 9 POBLACION, TIGBAUAN, ILOILO”

WHEREAS, the above-mentioned Barangay Ordinance was referred to the S.B. Committee on Rules, Ordinances, Resolutions and Legal Matters for review and recommendation and after careful study, the committee has the following findings, to wit:

The ordinance was presented in a PUBLIC HEARING last March 30, 2024 and is consistent with the provisions of Section 391 of the Local Government Code, to wit:

“SECTION 391. Powers, Duties and Functions. – (a) The sangguniang barangay, as the legislative body of the barangay, shall:

- (1) *Enact ordinances as may be necessary to discharge the responsibilities conferred upon it by law and ordinance and to promote the general welfare of the inhabitants therein;*
- (14)*Prescribe fines in amounts not exceeding One Thousand Pesos (P1,000.00) for violation of barangay ordinances;*
- (24)*Exercise such other powers and perform such duties and functions as maybe prescribed by law or ordinance;*

WHEREAS, the same is also consistent with SECTION 16 of the LGC which provides that every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of

appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

Ana Rowena Arias-Perera, Hon. Gaylord T. Trasporto and Hon. Florence Joy V. Cabalonga,

RESOLVED, to declare as **Legal** and **Valid** Barangay 9 (Poblacion), Tigbauan, Iloilo **Ordinance No. 2024-005** –*“An Ordinance Prohibiting and Removing Any Object Causing Obstruction/s on Streets, Sidewalks, Alleys, Parks and Other Similar Public Places Within the Area of Jurisdiction of Barangay 9 Poblacion, Tigbauan, Iloilo;”*
