RESOLUTION ADOPTING THE REGIONAL DEVELOPMENT COUNCIL RESOLUTION (RDC) NO. 21, SERIES OF 2024 -*“APPROVING THE BAN OF SINGLE-USE-PLASTIC AND STYROFOAM PRODUCTS IN ALL RDC MEETINGS AND ACTIVITIES, AND RECOMMENDING FOR THE REGIONAL LINE AGENCIES, STATE UNIVERSITIES, AND LOCAL GOVERNMENT UNITS TO ADOPT THE SAME”*

WHEREAS, waste reduction is a priority strategy under the Philippine Development Plan and Western Visayas Regional Development Plan 2023-2028, and is aligned with the Sustainable Development Goals (SDG’s) and other commitments of the government on climate change and sustainable production and consumption;
