RESOLUTION CONCURRING WITH THE APPOINTMENT OF JEANLYN TAÑEDO TORRICO, AS MUNICIPAL GOVERNMENT DEPARTMENT HEAD I (*MUNICIPAL HUMAN RESOURCE MANAGEMENT OFFICER*), SALARY GRADE 24-1, OF THE LOCAL GOVERNMENT UNIT OF TIGBAUAN, PROVINCE OF ILOILO, EFFECTIVE AUGUST 1, 2024.

WHEREAS, the vacancy on the position of the Municipal Government Department Head I (Municipal Human Resource Management Officer) was posted on July 5 to July 22, 2024;

WHEREAS, the position of Municipal Government Department Head I (Municipal Human Resource Management Officer), with a Salary Grade of SG 24-1, is a head of office position under the Office of the Municipal Human Resource Management Officer;

WHEREAS, Ms. Jeanlyn T. Torrico was unanimously recommended by the Human Resource Merit Promotion and Selection Board (HRMPSB) to occupy the position of MGDH I (*Municipal Human Resource Management Officer*), SG-24-1 during the deliberation of applicants on July 23, 2024;

WHEREAS, Ms. Jeanlyn T. Torrico has complied with the qualification standards of having at least four (4) years in position/s involving management and supervision as required by the CSC QS Revised 1997 and Memorandum Circular No. 12, s. 2022;

WHEREAS, Ms. Jeanlyn T. Torrico, has been performing the duties and responsibilities of the Human Resource Management Officer II and is in charge of the HRMO Services and Operations under the supervision of the Local Chief Executive through the Office Order No. 011, Series of 2018, dated February 1, 2018, up to the present;

WHEREAS, she is currently the Treasurer of the Human Resource Management Practitioners-Province of Iloilo, Inc;

WHEREAS, she has been proficient and has shown great innovations to human resource and management through continuous educational enhancement;

WHEREAS, Section 18, Rule VI of 2017 Omnibus Rules on Appointment and Other Human Resource Actions (Revised July 2018) states that, "In the case of local government units, the appointment issued by the appointing officer/authority to a department head position requires the concurrence of the majority of all the members of the local sanggunian;

WHEREAS, if the Sanggunian does not act on the appointment within fifteen (15) calendar days from the date of its submission, said appointment shall be deemed concurred and the effectivity date of the appointment shall be the date of the signing of the appointing officer/authority which shall end the moment the Sangguniang Bayan rejects or disapproves it;
