RESOLUTION RECOGNIZING TAGALIGTAS RIDERS PHILIPPINES INCORPORATED-ILOILO SOUTH CHAPTER AS A CIVIL SOCIETY ORGANIZATION IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, Article 62, Rule XIII of the Implementing Rules and Regulations of the Local Government Code of 1991 (Republic Act No. 7160) mandates local government units to promote meaningful participations of Community Based Organizations, Civil Society Organizations, Cooperatives, Non-Government Organizations, People’s Organizations and the Private Sectors to make them active partners in the pursuit of local autonomy and furtherance of development;

WHEREAS, on June 15, 2022, the Department of Interior and Local Government (DILG) issued Memorandum Circular No. 2022-083, on the Guidelines of the Accreditation and Recognition of Civil Society Organizations and Selection of Representatives to the Local Special Bodies;

WHEREAS, Tagaligtas Riders Philippines Incorporated, a non-stock corporation registered with the Securities and Exchange Commission (SEC), is a motorcycle group created to maintain a spirit of camaraderie, help disseminate information on safety riding, rider education, and skills development, and encourage the riding community to be disciplined, law-abiding and responsible motorcycle owners/riders;

WHEREAS, Tagaligtas Riders Philippines Incorporated-Iloilo South Chapter with chapter office address located at Barangay Namocon, Tigbauan, Iloilo, has signified their intention to be recognized in the Municipality of Tigbauan to pursue an active partnership with the Local Government Unit in the pursuit of local autonomy and nation building;
