RESOLUTION AUTHORIZING ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, TO GRANT FINANCIAL ASSISTANCE IN THE AMOUNT OF ONE HUNDRED THOUSAND PESOS (P100,000.00) IN CONNECTION WITH THE CASH FOR WORK PROGRAM FOR PERSONS WITH DISABILITY (PWD) IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO, CHARGEABLE AGAINST MSWDO-TRAINING EXPENSES

WHEREAS, in a letter dated August 8, 2024, the Local Chief Executive requested this Sangguniang Bayan for the URGENT passing of a *“Resolution Authorizing Atty. Virgilio T. Teruel, Municipal Mayor, To Grant Financial Assistance In The Amount Of One Hundred Thousand Pesos (P100,000.00) In Connection With The Cash For Work Program For Persons With Disability (PWD) In The Municipality Of Tigbauan, Province Of Iloilo, Chargeable Against MSWDO-Training Expenses;*

WHEREAS, the Kapisanan ng may Kapansanan sa Tigbauan, the active organization was organized to cater to the needs of the disabled persons to become productive and contributing members of the community regardless of their disabilities;

WHEREAS, in the Municipality of Tigbauan there are two thousand eighty six (2,086) persons with disability who applied for membership and have availed of the Magna Carta for Disabled Persons Benefits and Privileges. Out of this, there are eight hundred (800) active members;

WHEREAS, the Kapisanan ng may Kapansanan sa Tigbauan initiates programs to provide short-term intervention through temporary employment for no income and low income indigent PWDs or households, who are vulnerable, at risk, affected by the disaster, natural and/or human induced calamities, as well as climate change through Cash For Work;
