RESOLUTION AMENDING TEMPORARILY RULE VII, SECTION 14(b) OF RESOLUTION NO. 2022-083 OTHERWISE KNOWN AS THE INTERNAL RULES OF PROCEDURE OF THE SANGGUNIANG BAYAN OF TIGBAUAN, ILOILO BY TRANSFERRING THE REGULAR SESSION DAY (S.B’S 36TH REGULAR SESSION) FROM WEDNESDAY, SEPTEMBER 4, 2024, **TO TUESDAY, SEPTEMBER 3, 2024 AT 9:00 O’CLOCK IN THE MORNING.**”

WHEREAS, Rule VII, Section 14 par (b) of Resolution No. 2022-083 provides:

“RULE VII – REGULAR AND SPECIAL SESSIONS

Section 14. REGULAR SESSION

*(b.)The regular session shall be held every **Wednesday** and shall **start promptly at 9:00 o’clock in the morning.** Provided, however, that if the day falls on a holiday or the session is prevented by insuperable cause the next working day shall be the regular session day.*

WHEREAS, the upcoming SGLG National Validation will be held on September 4, 2024 at the S.B. Session Hall of this municipality;

WHEREAS, the members of this August, decided on consensus to amend temporarily said provision of S.B. Internal Rules of Procedure to accommodate the SGLG National Validators by transferring the regular session day (S.B’s 36th regular session) from September 4, 2024 (Wednesday), to September 3, 2024 (Tuesday);
