WHEREAS, Honorable Cornelia Teruel was a loving and devoted mother to four (4) children, namely: Jose Ronnel Teruel, Atty. Virgilio Teruel, who is our present Municipal Mayor, Ma. Juvy Teruel and Ma. Jeanette Teruel;

WHEREAS, the late Hon. Cornelia Torres-Teruel had dedicated her long years of life in the field of teaching where she poured with profound commitment the importance of moral values, principles and education to countless students in different places of assignments;

WHEREAS, the late Hon. Cornelia Torres-Teruel had served as Principal in various schools in the Municipalities of Carles, Dingle, Mina, San Miguel, and at Tigbauan High School from 1982 to 1991;

WHEREAS, it was during her stint as Principal when Tigbauan High School was nationalized and was renamed to Tigbauan National High School;

WHEREAS, with her nature and desire to serve people, she was elected as Sangguniang Bayan Member for three (3) consecutive terms from 1992 to 1995, from 1995 to 1998, and from 1998 to 2001;

WHEREAS, during her term, she was known as a dedicated and efficient Sangguniang Bayan Member and was one of the most sought-after public official for being amiable, compassionate, accommodating and effective performer;

WHEREAS, during her three (3) consecutive terms of service as Sangguniang Bayan Member, she was able to effectively contribute to the Council by passing significant ordinances and resolutions and had been an active participant in different government & non-government programs to uplift lives and well-being of many Tigbauanons, thereby exemplifying the true essence of public service;

WHEREAS, on August 23, 2024, the Torres-Teruel Family mourned as the former public servant has rested eternally to join our Creator;

WHEREAS, her legacy and leadership have greatly contributed to the progress of the Municipality of Tigbauan and to the preservation of its culture and tradition, worthy of remembrance and emulation; her dedication will forever be etched in the minds and hearts of every Tigbauanon.
