RESOLUTION CONFORMING AND APPROVING THE CY 2024 SUPPLEMENTAL BUDGET OF BARANGAY BARROC OF THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on September 17, 2024 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization, the CY 2024 Supplemental Budget of Barangay Barroc, this municipality to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace;
