RESOLUTION ADOPTING REPUBLIC ACT NO. 10354, OTHERWISE KNOWN AS THE "RESPONSIBLE PARENTHOOD AND REPRODUCTIVE HEALTH ACT OF 2012" IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, pursuant to Section 12, Article II of the 1987 Philippine Constitution, it is the duty of the State to protect and strengthen the family as a basic autonomous social institution and shall equally protect the life of the mother and the life of the unborn from conception;

WHEREAS, Republic Act No. 10354, otherwise known as *"The Responsible Parenthood and Reproductive Health Act of 2012"* provides that the State shall recognize and guarantee the human rights of all persons including their right to equality and nondiscrimination of these rights, the right to sustainable human development, the right to health which includes reproductive health, the right to education and information, and the right to choose and make decisions for themselves in accordance with their religious convictions, ethics, cultural beliefs, and the demands of responsible parenthood;

WHEREAS, Reproductive Health (RH) refers to the state of complete physical, mental and social well-being and not merely the absence of disease or infirmity, in all matters relating to the reproductive system and to its functions and processes;

WHEREAS, Family Planning refers to a program which enables couples and individuals to decide freely and responsibly the number and spacing of their children and to have the information and means to do so, and to have access to a full range of safe, affordable, effective, non-abortifacient modem natural and artificial methods of planning pregnancy;

WHEREAS, the adoption of R.A. 10354 is essential for the effective and efficient implementation of family planning programs in the municipality and foster the importance of reproductive health among its constituents;

NOW, THEREFORE, on motion of HON. ANA ROWENA A. PERERA, *Chairperson,* S.B. Committee on Health and Sanitation and duly seconded by Hon. Adrian S. Camposagrado, Hon. Neri T. Camiña, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares, Hon. Joel L. Sayson, Hon. Gaylord T. Trasporto and Hon. Florence Joy V. Cabalonga,
