WHEREAS, Section 7, Article V of Republic Act No. 11927 or otherwise known as an “Act to Enhance the Philippine Digital Workforce Competitiveness, Establishing for the Purpose an Inter-agency Council for Development and Competitiveness of Philippine Digital Workforce and For Other Purposes” mandates that all LGUs shall create local policies supporting and promoting the growth and development of digital technology;
