**Resolution No. 2024-160**

RESOLUTION CONFORMING AND APPROVING THE CONDUCT OF S.B. MARATHON SESSIONS FOR THE MONTH OF NOVEMBER 2024 TEMPORARILY TRANSFERRING THE REGULAR SESSION DATES TO COMPLY WITH SEC. 52 (A) OF RA 7160.

WHEREAS, Rule VII, Section 14 of Resolution No. 2022-077 (entitled: “RESOLUTION ADOPTING THE INTERNAL RULES OF PROCEDURE OF THE SANGGUNIANG BAYAN OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO”) states, to wit:

**RULE VII – REGULAR AND SPECIAL SESSIONS**

**Section 14. REGULAR SESSION** - The minimum number of regular sessions of the Sanggunian shall be “once a week”.

- (a) The regular session shall be held every Monday and shall start promptly at 9:30 in the morning.  
Provided, however, that if the day falls on a holiday or the session is prevented by insuperable cause the next working day shall be the regular session day.

WHEREAS, on July 11, 2022, this August Body amended the aforementioned provision by passing Resolution No. 2022-083, to amend Rule VII, Section 14(a) of Resolution No. 2022-077, transferring the regular session day from “...every Monday, 9:30 in the morning.” to “...every Wednesday at 9:00 o’clock in the morning”;

WHEREAS, in order to attend to their hectic schedules and various official and personal activities during this Christmas Season, to include the S.B. Year-End Assessment, Planning and Review, the members of this August Body deem it proper to amend the said provision of the Internal Rules of Procedure by holding marathon regular sessions this November 2024 with the following schedules:

WHEREAS, the holding of these marathon sessions, other than the scheduled session dates every Wednesdays (to include 2 additional session days on November 11 (Monday) and November 18 Monday)) is in compliance with **Section 52 (a) of R.A. 7160**, to wit:

*“On the first day of the session immediately following the election of its members, the sanggunian shall, by resolution, fix the day, time, and place of its regular sessions. The minimum numbers of regular sessions shall be **once a week** for the sangguniang panlalawigan, sangguniang panlungsod, and **sangguniang bayan**, and twice a month for the sangguniang barangay”;*

WHEREAS, to promote public service and to ensure attendance of the members of the Sangguniang Bayan during sessions, it is imperative that the abovestated schedules be adopted;

NOW, THEREFORE, on motion of HON. ADRIAN S. CAMPOSAGRADO, Chairman, S.B. Committee on Rules, Ordinances, Resolutions and Legal Matters and duly seconded by Hon. Neri T. Camiña, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma Hon. Norberto T. Turalba, Hon. Jerry T. Tuares, Hon. Joel L. Sayson, Hon. Ana Rowena A. Perera, Hon. Gaylord T. Trasporto and Hon. Florence Joy V. Cabalonga,

RESOLVED, to conform and approve the Conduct of S.B. Marathon Sessions for the Month of November 2024 and Temporarily Transferring the Regular Session Dates to Comply with Sec. 52 (A) of RA 7160;
