RESOLUTION CONFORMING AND APPROVING THE CY 2024 SUPPLEMENTAL BUDGET OF BARANGAYS, BINALIUAN MAYOR, NAGBA, BAROSONG, CORDOVA NORTE AND 6 POBLACION OF THIS MUNICIPALITY

WHEREAS, the Municipal Budget Officer on October 2, 2024 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization, the CY 2024 Supplemental Budget of the aforementioned Barangays, this municipality to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace;

The appropriation of Brgy. Binaliuan Mayor for Supplemental Budget No. 2024-001 embodying Appropriation Ordinance No. 2024-001 - in the amount of 970,000.00 is for the Travelling Expense-35,000.00, Training Expense-35,000.00, and Procurement of Barangay Monitoring Vehicle - 900,000.00, chargeable against CY 2018-2023 BDRRM Trust Fund, Continuing Appropriations CY 2022-2023 20% Development Fund and CY 2023 Retained Operating Surplus (PS & MOOE):

The appropriation of Brgy. Nagba for Supplemental Budget No. 2024-001 001 embodying Appropriation Ordinance No. 2024-001 - in the amount of 240,000.00 is for the Travelling Expense-30,000.00, Training Expense-35,000.00, Electricity Expense-40,000.00, Telephone Expense-5,000.00, Construction of Concrete Fence - 130,000.00, chargeable against Reprogramming of CY 2024 20% Development Fund-Completion of Multi-Purpose Hall and CY 2023 Revenue and Retained Operating Surplus (PS & MOOE):

The appropriation of Brgy. Barosong for Supplemental Budget No. 2024-001 001 embodying Appropriation Ordinance No. 2024-001 - in the amount of 140,000.00 is for the Travelling Expense-25,000.00, Training Expense- 50,000.00, Electricity Expense-65,000.00, chargeable against CY 2023 Retained Operating Surplus (PS & MOOE):

The appropriation of Brgy. Cordova Norte for Supplemental Budget No. 2024-001 001 embodying Appropriation Ordinance No. 2024-001 - in the amount of 400,000.00 is for the Travelling Expense-15,000.00, Training Expense-70,000.00, Office Supplies - 5,000.00, Electricity Expense-42,000.00, R/M-Other Infrastructure 40,000.00, Cultural Activities- 20,000.00, Other MOOE-2,000.00, Disaster Response and Rescue Equipment - 200,000.00, chargeable against CY 2023 Revenue Surplus, Retained Operating Surplus (PS & MOOE) and CY 2020-2023 BDRRM Trust Fund:

The appropriation of Brgy. 6 Poblacion for Supplemental Budget No. 2024-001 001 embodying Appropriation Ordinance No. 2024-001 - in the amount of 150,000.00 is for the Travelling Expense-20,000.00, Training Expense-50,000.00, Office Supplies-5,000.00, Electricity Expense-5,000.00, Cultural Activities -10,000.00, Other MOOE-11,000.00, Disaster Response and Rescue Equipment - 40,000.00, chargeable against CY 2022 Revenue Surplus, Retained Operating Surplus (MOOE) and CY 2020-2023 BDRRM Trust Fund.

WHEREAS, the Municipal Budget Officer had reviewed in advance and endorsed to this August Body the aforementioned Barangays Supplemental Budget which show apparent compliance with the provisions of the 1991 Local Government Code and its Implementing Rules and Regulations;

WHEREAS, the review of the foregoing documents/Supplemental Budgets likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;
