RESOLUTION AUTHORIZING ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, TO GRANT LIVELIHOOD ASSISTANCE IN THE AMOUNT OF ONE HUNDRED FORTY FIVE THOUSAND PESOS (P145,000.00) TO TWENTY (20) PANTAWID PAMILYANG PILIPINO PROGRAM (4Ps) BENEFICIARIES (GRADUATED/EXITING HOUSEHOLDS) AND NINE (9) SOLO PARENTS IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, in a letter dated October 21, 2024 addressed to the Sangguniang Bayan, the Local Chief Executive requested for the passing of the aforesaid resolution;

WHEREAS, Article XII, Section 1 of the 1987 Philippine Constitution states that, *“the goals of the national economy are a more equitable distribution of opportunities, income, and wealth; a sustained increase in the amount of goods and services produced by the nation for the benefit of the people; and an expanding productivity as the key to raising the quality of life for all, especially the underprivileged”*;

WHEREAS, the Department of Social Welfare and Development (DSWD) implemented the Sustainable Livelihood Program (SLP), a capacity-building program for the poor, vulnerable and marginalized households and communities to help improve their socio-economic conditions through accessing and acquiring necessary assets to engage in and maintain thriving livelihoods;

WHEREAS, the Livelihood Assistance Grant (LAG) is a form of financial assistance of the DSWD under the SLP which provides economic recovery/rehabilitation support to eligible families whose livelihoods suffered economic losses;

WHEREAS, the Municipality of Tigbauan has a total of one hundred twenty two (122) exiting household beneficiaries who will be graduated from the Pantawid Pamilyang Pilipino Program (4Ps) and two hundred thirty one (231) registered solo parents;

WHEREAS, out of the 122 exiting 4Ps household beneficiaries and 231 registered solo parents in the municipality, there were twenty (20) exiting 4Ps household beneficiaries and nine (9) solo parents respectively with existing micro-enterprise business who were qualified for the livelihood assistance grant;

WHEREAS, through the provision of the Livelihood Assistance Grant, the LGU will be able to provide support services to the twenty (20) exiting 4Ps household beneficiaries and nine (9) solo parents with existing micro-enterprise business so they may be able to recover and improve their livelihood and well-being;

NOW, THEREFORE, on motion of HON. ANA ROWENA A. PERERA, Chairperson, Committee on Women, Family, Social Services and Indigents, and duly seconded by Hon. Neri T. Camiña, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Norberto T. Turalba, and Hon. Florence Joy V. Cabalonga;

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Bayan to authorize Atty. Virgilio T. Teruel, Municipal Mayor, To Grant Livelihood Assistance In The Amount Of One Hundred Forty Five Thousand Pesos (P145,000.00) To Twenty (20) Pantawid Pamilyang Pilipino Program (4Ps) Beneficiaries (graduated/exiting households) and Nine (9) Solo Parents In The Municipality Of Tigbauan, Province Of Iloilo;

RESOLVED FURTHER, to furnish copies of this Resolution to the Office of the Municipal Mayor, to the Municipal Social Welfare and Development Office, and to all concerned for their information and/or appropriate action.
